
## What Is Torn Down, Must Be Rebuilt

# IDEA to Health and Human Services?

Before there was a Department of Education (think pre-1980), there was an Office of Education, established into law by Andrew Johnson in 1867. The Office bounced around a little but eventually settled into the Department of Health Education and Welfare now known as the Department of Health and Human Services (HHS). Robert F. Kennedy Jr. was recently confirmed as the secretary of HHS. There is a lot to discuss about RFK Jr.'s views on a whole range of topics but let's focus on what Department of Education Secretary nominee Linda McMahon said in her confirmation hearing that IDEA would "rest better" in HHS. What does she mean by that and what are the potential impacts of a move like that for students with service and support needs at school?

Let's start with RFK's core beliefs:

1. Robert F. Kennedy Jr believes [vaccines cause autism and has a record of disparaging remarks about the autistic community](#)
2. He advocates for "wellness farms" - [an institutionalization approach popular in the 1800s](#)

There are more causes for concern but this is a newsletter, not a book, so let's just focus on why these two things combined are bad for the watchdog of the Individuals with Disabilities Education Act (IDEA).

Remember, the ED does not determine curriculum or standards (that's already under local control - someone should remind the GOP and the Secretary nominee). It provides less than 10% of essential funding for most schools, funds approximately 14% of IDEA services, oversees implementation of the Elementary and Secondary Education Act (ESSA), IDEA, collects data on public education, and [disseminates research funds](#).

Specifically for IDEA, the Department of Ed provides oversight and holds states accountable for providing education to all students with disabilities. In a [NewAmerica article](#), Carrie Gillispie says, *The critical federal role in four key areas of special education are at risk if the Trump administration dismantles ED: administering federal funding fairly; identifying civil rights violations; providing funding and guidance for improving special education; and ensuring nationwide consistency.*

That's concerning enough without The HHS Secretary's ableism and history of anti-science beliefs. It also positions disability at school within the medical model (IDEA is written this way, too, but it is important that we consider the social implications of educational exclusion and segregation).

IDEA is an educational civil rights law. It was written and implemented to give students with disabilities access to a free and appropriate public education within the general education classroom. Let's not let them forget that.
